We said in the Updates and ALERTS that we were at 2 key points in the last 6 weeks and both turned out to be exactly what we expected. First, the SPX 4100 area was the LAST STAND for the bears and they could not crack it. Second, SPX 4600 was the next LAST STAND for the bears as a double top was formed with RSI divergences. If the 10 yr Treasury can't hold the 3.90% area, a move to 3.50% -3.25% not off table. YIELD CURVE inverted. JP OBSESSED with soft landing???

International US Dollar- As expected lower rates great for EM and elsewhere BUT not good for US Dollar (we said 108 area top and now we hold 100-102 or a 95 handle in 2024 not off table. SHORT TERM watch 110 area on the EURO for potential rollover IF we hold 100-102 on Dixie.

Speculation- We told you of spike in GOLD and also the SUPPORT at \$1950-\$1990 which held so far. Easy money budget deficits-Gold likely:.)
Crude Oil HELD SUPPORT at 68.80 and with crude inventories down, the oil shares may do well in 2024 as stimulating China's economy and loose money here with full employment and drunken sailor consumer spending may give oil demand a lift...they're starting to move—spring??

GBTC and ETHE have soared ahead of the potential ETF in January and halving. Now, you throw in fiat money gone wild BUT time to hedge???
